Council meeting February 24 – agenda available online

The Nova Scotia Barristers' Society will hold a Council meeting this Friday, February 24. The agenda is available for viewing on the **Council materials** webpage: <http://nsbs.org/council-materials>.

Nominations for Second Vice-President: 2012/2013

Memorandum from Marjorie Hickey QC, Chair, Governance and Nominating Committee

The Governance and Nominating Committee wishes to advise that it has nominated **Tilly Pillay QC** of Halifax for Second Vice-President of the Society for the 2012/2013 Council year.

Ms. Pillay completed her undergraduate education at Dalhousie University, earned two Master of Arts degrees from Cambridge University and the University of Toronto, and then completed her LLB at Dalhousie Law School in 1989. After articling in Nova Scotia and Ontario, she was admitted to the Nova Scotia Bar in 1990 and worked for five years as a staff lawyer with Nova Scotia Legal Aid.

In 1995 she joined the Nova Scotia Department of Justice and held varying positions as a solicitor and as a litigator. In 2002 she was appointed a Director of the Legal Services Division, where in addition to carrying case files, she had management responsibilities for lawyers and staff. She completed extensive management and leadership training, and earned a Certificate in Leadership Development through Saint Mary's University. Currently, Ms. Pillay holds the positions of Director of Litigation and Co-Executive Director of the Legal Services Division.

Ms. Pillay has been involved in a number of community organizations, where she was a past member of the Board of Directors of Bryony House, a volunteer with the Metropolitan Immigrant Settlement Association, and a member of the Board of Directors for LISNS. In addition to being a member of the Canadian Bar Association for most of her practising years, Ms. Pillay has been actively involved in the work of the Nova Scotia Barristers' Society, where she was a member of Council from 2007 to 2009, a member of the former Discipline Committee, the Supreme Court (Family Division) Liaison Committee, the Hearing Committee and, currently, the Complaints Investigation and the Family Court Liaison Committees. As a member of the Hearing Committee, Ms. Pillay sat on several panels where complaints were adjudicated.

Ms. Pillay has authored various papers for presentation at CLE conferences and has published a Handbook for Lawyers relating to the Maintenance Enforcement Program, which now forms part of the Bar Admission materials. Outside her many legal interests, she is an active mother for two busy boys, and enjoys reading, exercise and travel.

Pursuant to subregulations 2.7.2 – 2.7.5 and s. 8(1) of the *Legal Profession Act*, members of the Society may now nominate other candidates for the office of Second Vice-President.

The closing date for nominations is **March 15, 2012**. The [Nomination Form](#) is available on the website.

The applicable regulations state:

2.7.2 On or before the fifteenth day of February each year, the Nominating Committee shall advise members of the Society of its nomination for Second Vice-President.

2.7.3 A candidate for Second Vice-President may be nominated by forwarding to the Executive Director, before the fifteenth day of March each year,

- (a) a nomination form signed by ten members of the Society, not more than five of whom practise primarily in the same district as the candidate; and
- (b) a consent form signed by the candidate.

2.7.4 No nomination shall be accepted for Second Vice-President that would result in a contravention of Section 8(1) of the Act if the nominee were elected the Second Vice-President.

2.7.5 If no nomination is received pursuant to subregulation 2.7.3, the candidate nominated by the Nominating Committee shall be declared elected.

Section 8(1) of the *Legal Profession Act* requires that at least one Society officer reside outside Halifax. With Tim Daley QC, the incoming President, living in New Glasgow, a nominee may reside in any area of the province.

Election dates

If an election is to be held, ballots will be made available to the membership **on or before the 1st of April, 2012**. The 2012/2013 Council year begins in June. Tim Daley QC of New Glasgow will serve as President, with Rene Gallant of Halifax as First Vice-President.

Additional information for candidates

For the information of prospective candidates for Second Vice-President, the Governance and Nominating Committee has set the following guidelines:

- Any candidate who is nominated for Second Vice-President will be able to have material posted on an Election Site on February 22 or within 72 hours of receipt of those materials by the Society, if receipt is after that date.
- The space for candidates will be available on the election page on the Society's website that will ensure:
 - a consistent format for tombstone information about the candidate (name, firm, nature of practice, etc.);
 - the candidate will be able to provide text of an election message or essay;
 - the candidate will be free to provide links to other sources of information, but only the election text/essay will be posted on the Society's site; and
 - candidates may publish only one photo on the election site.
- On receipt of a nomination, the Executive Director will provide:
 - information regarding posting of material on the Society's website;
 - a voters' list including the name, firm, address, email address and phone number of practising lawyers;
 - clarification that information regarding non-practising members is not available in this format; and
 - a requirement for written confirmation that the candidate will use the information solely for the purpose of the election and agrees to destroy the database at the conclusion of the election.
- No information about who has voted will be available after the commencement of the election.

Notice to the Profession: Amendments to Subregulation 4.2.8 – Duty to Report

Council has passed amendments to Subregulation 4.2.8 to require lawyers to report criminal or quasi-criminal charges to the Society.

The Professional Responsibility Policies and Procedures Committee reviewed the applicable provisions in all other Canadian provinces and noted that Nova Scotia was the only jurisdiction that did not require its members to report criminal or quasi-criminal charges to the Society. While the Society often learns of charges through self-reporting or the media, it is possible that lawyers could face serious charges that may impact their practices, issues of public protection and/or the reputation of the legal profession without the Society having any notice.

It is possible that a report of charges could become the subject of an investigation pursuant to Subregulation 9.2.1.

Please note that if a lawyer is convicted of a criminal offence, the Complaints Investigation Committee may hold a hearing pursuant to Section 38 of the *Legal Profession Act*, which requires the lawyer to establish why the Complaints Investigation Committee should not begin an investigation into the matter. As in every case where a lawyer is found guilty or convicted of a criminal or other offence, the Complaints Investigation Committee considers all relevant factors and circumstances and determines whether any further action is warranted in the public interest.

Notice to Profession: Time is running out – NSBS Mandatory Assessment for new Code of Professional Conduct

If you haven't completed the mandatory online assessment regarding the new NSBS *Code of Professional Conduct*, this is a gentle reminder! For those of you who have completed it already, well done.

The new *Code of Professional Conduct* came into effect on January 1, 2012. While there are only a few substantive changes to the rules of conduct, the *Code* has a new format and it is important that all lawyers and articled clerks become familiar with it and the changes approved by Council.

The Society launched a mandatory online assessment on its website on November 7, 2011. All practising lawyers **and clerks must complete this assessment no later than April 30, 2012.**

An Executive Summary highlighting the changes to the rules of ethics in the new *Code* is also available at <http://nsbs.org/regulation>. Instructions for completing the assessment were emailed to members and clerks in early November.

To complete the assessment, **you must use the assessment link in the original message** sent to you. If you have lost this message, contact the Society to have it retransmitted.

(Please note, the link to the Code in the original email is now outdated since the launch of the Society's new website; the Code is accessible anytime on the Regulation page at <http://nsbs.org/regulation>.)

The assessment will guide you through the new *Code* and its changes, and takes about 30 minutes to complete. So don't delay. It is your professional duty to be fully familiar with the current rules of ethics, and the sooner you get on board the better.

Frederick B. (Ted) Wickwire was educated in Halifax and received his Bachelor of Commerce degree in 1959 and his Bachelor of Laws degree in 1962 from Dalhousie University, and practised in the field of corporate and commercial law with a special interest in property rights. He was appointed Queen's Counsel in 1978. His service to Dalhousie University involved thirteen years as a member of the Board of Governors.

He was senior partner in the firm of MacInnes Wilson Flinn Wickwire. In 1977, he was appointed the first Chairman of the Nova Scotia Legal Aid Commission. Mr. Wickwire worked tirelessly to ensure that Nova Scotia barristers maintained a level of uncompromised professionalism. To this end he served as chairman of the Nova Scotia Barristers' Society's Legal Ethics Committee, and oversaw the creation of a new handbook on ethics and professional conduct for Nova Scotia lawyers. His service to the legal profession culminated in his election as President of the Barristers' Society in June 1990, a position he held at the time of his death on March 22, 1991.

For his work with both the Nova Scotia Barristers' Society and the development of Legal Aid in Nova Scotia, he won the Weldon Award for Unselfish Public Service from the Dalhousie Law School Alumni Association posthumously in October 1991.

Request for applications for provincial judicial vacancies

Under the Guidelines, applications for a dual appointment as a Provincial Court and Family Court judge are accepted by the Provincial Judicial Appointment Committee at any time and remain on file for a period of three years from the date of the application.

As these Guidelines came into effect in April of 2009, there are applications about to expire and those candidates affected are encouraged to reapply. Presently it is anticipated that the Provincial Judicial Appointment Committee will be reviewing applications again the first of April, 2012. Although applications can be accepted at any time, new applications and those being resubmitted must be received by April 2, 2012 in order to be reviewed by the Committee at this time.

Staff of the Canadian Securities Administrators (CSA), which includes the Nova Scotia Securities Commission, are conducting a review of the minimum amount prospectus exemption and the accredited investor prospectus exemption contained in National Instrument 45-106 Prospectus and Registration Exemptions. At the conclusion of the review, CSA staff may recommend either retaining the exemptions in their current form or may propose changes.

The imaginary normal

The joke goes like this: “The optimist says the glass is half-full. The pessimist says it’s half-empty. The engineer says it’s twice the required capacity.”

So what does the lawyer say when looking at the glass? In many cases, it’s: “Why hasn’t anyone refilled my drink yet?”

I speak to more lawyers and legal professionals every day who really get it — who understand how much is changing and who are preparing to adjust and respond. I can’t tell you how encouraging that is to me.

But I’m still taken aback by the number of lawyers and legal professionals who cannot or will not recognize what’s happening — who look at the market and see only what they want to see, interpreting a storm of the century as merely a passing squall.

For many such lawyers, I've come to conclude, the underlying cause of that delusion is a sense of entitlement. They're entitled to respect for their position, steady work from clients, protection from unqualified competition, privilege at the top of the pyramid, stability in an unstable world.

And why should they think different? It's all they've ever known and it's rewarded them handsomely, so of course they believe it's the natural order of things. They believe it's normal, and they're waiting impatiently for it to return.

Here's what I want them to understand: It's not normal. It never was.

The legal market hasn't really been a "market," in classical terms, at all. It's been artificially constrained for decades by asymmetric knowledge, inadequate technology, limited competition, undifferentiated providers, seller-driven pricing, and most damaging of all, the absence of disinterested regulators. Accordingly, buyers have long suffered from weak bargaining positions and low self-confidence. Why, when you stop and think about it, would we ever have supposed that was normal?

The legal profession has been living inside a bubble for decades. And like all bubbles, those on the inside thrived disproportionate to the overall benefits they were delivering, while resentment and frustration continually grew on the outside. And we had no clue, because we figured that was how it was meant to be.

But now that's changing. Consumers are gaining more knowledge and more choice, giving them more power. The bubble is leaking. The traditional mechanics of healthy markets, by which sellers truly compete with each other to gain the business of well-informed buyers on the buyers' terms, are reasserting themselves. A legal marketplace that has always been tilted in lawyers' favour is rebalancing itself.

This isn't a market going crazy. It's a market going normal. And it's not going back.

Dalhousie research finds cannabis use doubles risk of a motor vehicle crash

Drivers who consume cannabis within three hours of driving are nearly twice as likely to cause a motor vehicle crash (MVC) as those who are not under the influence of drugs or alcohol, according to new research from Dalhousie University.

Dr. Mark Asbridge, associate professor in Dalhousie Medical School's departments of Community Health & Epidemiology and Emergency Medicine, completed a systematic review and meta-analysis of nine studies to determine if cannabis use increases the risk of a MVC.

CanLII: One million Canadian judgments (17,305 Nova Scotian) now freely available

On Friday, February 17, CanLII loaded its one millionth judgment, a decision of the Supreme Court of Canada. It has taken 12 years for CanLII to reach the one million mark, a total that includes judgments from more than 200 legal sources.

According to Colin Lachance, President and CEO of CanLII, "reaching the million mark has involved adding both new and historical judgments to the database." Mr. Lachance adds, "CanLII now grows by more than 120,000 judgments a year, approximately 20 per cent of which are older cases that add depth to our collection."

The collection of Nova Scotia decisions on CanLII dates back further than most provinces. This is due to the work of the Society's Library & Information Services (L&IS) staff. The Society's collection of print decisions digested in *Nova Scotia Law News* dates back to the early 1970s.

In 2008, L&IS undertook a de-identification project to anonymize Nova Scotia family and young offender decisions that for various reasons could not be posted online.

Over the course of the project, approximately 1,100 anonymized decisions were added to CanLII. Previously, these decisions were only available in hard copy at the Nova Scotia Barristers' Society Library in Halifax.

This work was done in conjunction with another project in which L&IS staff converted nearly 4,500 Court of Appeal and Supreme Court decisions dating back to 1990 from print to electronic format. From 2001 to 2009, all Nova Scotia court decisions available on the service were sent to CanLII by Library & Information Services (L&IS).

CanLII's one million decisions include 17,305 Nova Scotia decisions, with roughly one-third of those decisions freely available on CanLII thanks to the L&IS conversion and de-identification projects, and much of the remainder available due to the work of L&IS staff over eight years.

In 2008, the Ethics and Religious Culture (“ERC”) Program became mandatory in Quebec schools, replacing Catholic and Protestant programs of religious and moral instruction. L and J requested that the school board exempt their children from the ERC course putting forward the existence of serious harm to the children within the meaning of s. 222 of the *Education Act*. The director of educational resources for young students denied the exemptions. L and J requested that the school board’s council of commissioners reconsider that decision, and the council of commissioners upheld this decision. L and J then turned to the Superior Court seeking both a declaration that the ERC Program infringed their and their children’s right to freedom of conscience and religion, and judicial review of the decisions denying their requests for exemption from the ERC course. They claimed that these decisions had been made at the dictate of the Ministère de l’Éducation, du Loisir et du Sport (“Ministère”). The Superior Court dismissed the motion for declaratory judgment and the motion for judicial review. Upon motions being brought by the school board and the Attorney General of Quebec to dismiss the appeal, the Court of Appeal refused to hear L and J’s appeal as of right and also dismissed their motion for leave to appeal.

Held: The appeal should be dismissed.

The appeal from the judgment of the Supreme Court of Newfoundland and Labrador - Court of Appeal, Number 10/26, 2011 NLCA 24, dated April 8, 2011, was heard this day and the following judgment was rendered orally:

Deschamps J. – We agree with Hoegg J.A., dissenting at the Court of Appeal, that the trial judge committed no reviewable error. Therefore, the appeal is allowed.

Having heard the parties, we also agree with the dissenting judge that Count No. 1 should be stayed and that the convictions on the other Counts should be restored.

Criminal law — Evidence — Testimonial competence — Adults with mental disabilities — Whether adult witnesses with mental disabilities must demonstrate understanding of nature of obligation to tell truth in order to be deemed competent to testify — Whether finding of testimonial competence without demonstration of understanding of obligation to tell truth breaches accused's right to fair trial — Canada Evidence Act, R.S.C. 1985, c. C-5, s. 16.

The Crown alleges that the complainant, a 23-year-old woman with the mental age of a three- to six-year-old, was repeatedly sexually assaulted by her mother's partner during the four years that he lived in the home. It sought to call the complainant to testify about the alleged assaults. After a *voir dire* to determine the complainant's capacity to testify, the trial judge found that she had failed to show that she understood the duty to speak the truth. In a separate *voir dire*, the trial judge also excluded out-of-court statements made by the complainant to the police and her teacher on the grounds that the statements were unreliable and would compromise the accused's right to a fair trial. While the remainder of the evidence raised some serious suspicions about the accused's conduct, the case collapsed and the accused was acquitted. The Ontario Court of Appeal affirmed this result.

Held (Binnie, LeBel and Fish JJ. dissenting): The appeal should be allowed, the acquittal set aside and a new trial ordered.

The Canadian Radio-Television and Telecommunications Commission referred to the Federal Court of Appeal the question of whether retail Internet Service Providers ("ISPs") carry on, in whole or in part, "broadcasting undertakings" subject to the *Broadcasting Act* when, in their role as ISPs, they provide access through the Internet to "broadcasting" requested by end-users. The court held that they do not.

Held: The appeal should be dismissed.

A new client representation request involving a breach of contract has been circulating this week. The wording is as follows:

This breach of contract scam attempt follows the same 'process' we're all familiar with by now: a series of emails requesting representation in a business transaction, accompanied by seemingly legitimate-looking identity or supporting documents. Very soon after, a fraudulent cheque is received and bank deposit instructions are sent to the lawyer.

Refamiliarize yourself with **Client ID Regulation 4.5.11**. It requires that in a non-face-to-face transaction involving a client who is not present in Canada, identity verification must be carried out by an agent on behalf of the lawyer. Often in these scams, potential clients will not be willing to have you retain the verification agent or comply overall with the Client ID Regulations. It is best to advise the client that the transaction will not be completed until they comply with the regulation. Find Regulation 4.5.11, sample verification agreements and more under the NSBS [Client ID Regulations](#).

Keep in mind these potential red flags when you are contacted:

- Client is offshore, unknown to the firm and often in a rush to complete the transaction.
- Client readily agrees to pay a seemingly high rate of fees from the funds that you are to secure for them.
- The debtor will often send a payment cheque promptly, with little to no persuasion. This is suspicious considering the client's dire need to retain you initially.

Use Google to verify phone numbers, addresses and email contacts. If you do decide to proceed with the transaction, when the cheque is received, be sure to go to the bank website to verify the branch transit number, address and phone number on the cheque. Hold onto the funds until the bank confirms that the funds are legitimate and that it's safe to withdraw from the deposit.

Be cautious with all cheques received, especially if they exceed the agreed-upon amount. Where possible, use the [Large Value Transfer System \(LVTS\)](#), an electronic funds transfer system that allows large payments to be exchanged securely and immediately.

- **Step back,** think, and count to a high number when you become frustrated.
- **Make eye contact with your newborn.** Babies talk with their eyes.
- **Relax and enjoy the journey.** Make it a daily habit to play with your new baby and let him fall asleep on your chest.
- **Treasure each moment.** Remember that trying times pass.

The most important preparation takes place in a new father's mind. When your little one arrives, you want to be ready. Absorb all the information you can by learning from other dads. Or enrol in a workshop for new dads on the basics of caring for the newborn and bonding with your child.

Your baby will naturally help bring out the best in you. Dads understand this only when they get the first chance to hold their newborn and they begin to feel the love that has motivated men for centuries to protect and provide for their children.

Making the most of fatherhood

- **Consider shifting roles and taking on new responsibilities.** Before the birth of their first child, it is important for new dads to assume new household responsibilities and duties. Whether it is washing the dishes, vacuuming or cooking dinner, it is important for new dads to help out in any way possible.
- **Learn from watching.** Many new dads decline to take part in several activities associated with parenthood because they are unsure of what they are doing. As with a new sport or any type of new activity, it is important to observe the activity and then try it.
- **Be sensitive to mom's emotions.** After nine months of pregnancy, and then giving birth to a child, many recent mothers experience a range of emotions. Extreme highs and lows occur randomly and frequently after childbirth. Consequently, it is important for new dads to be sensitive to these emotions, to be supportive, and to listen to the new mom's concerns. Beyond the changes in mom's emotions, new dads may find that their own feelings and emotions have become unpredictable.
- **A time of change.** Mood shifts and erratic feelings are rather common both for new dads and moms after childbirth. However, this should not continue for an extended period after childbirth. If either parent continues to experience abnormal feelings and cannot regain emotional stability, she or he should speak with a professional.
- **Staying connected.** A good relationship requires time and intimacy – things that are often difficult for new parents. Researchers have identified the transition to parenthood as one of life's most challenging milestones that can either bring couples closer together or push them apart. Prepare by analyzing the changes that your lifestyle may go through and have realistic discussions about the division of chores. Think ahead about potential stress points. After the baby has arrived, make spending quality time alone together a priority and you'll find a way to make it happen.

Heros in our own lives: Janie Justice, Gloria Steinem and Wonder Woman

"I thought at least the NSBS (GEC, etc.) understood. Then I got the *Society Record*. 'Janie Justice,' LLB(arbie). Teeny waist, balloon breasts. Female lawyers as a cartoon joke ...what's wrong with a REAL woman on the cover?"

It would be fair to say there was some negative response to Janie, both in postcards and from women in the profession I have spoken to. I heard feedback that the image was an objectification that did not serve to promote equality for women lawyers.

I didn't have that reaction to Janie, and it got me to thinking, why not? I think it was because what I saw was a female, lawyer, superhero.

Female superheroes in popular culture make for an interesting study. At the dawn of the comic era, there were few – you were more likely to find girlfriends with weak ankles like Lois Lane, or add-ons like Batgirl or Supergirl.

The exception, and first real female superhero, was Wonder Woman. Created in the early 1940s, the character was an Amazon princess, and a strong and independent woman – at least initially. Not surprisingly, by the '60s, Wonder Woman had been stripped of her superpowers and thought mostly about marriage. She was in the Justice League – as the secretary

Enter – and I'm not kidding about this – Gloria Steinem. Steinem was a fan of the original Wonder Woman creation. In fact, Wonder Woman is on the cover of the premier issue of *Ms. Magazine* in July of 1972, under the caption, "Wonder Woman for President". Steinem saw her as a symbol for a strong independent feminist.

When I look at Janie, I see a superhero. I see a lawyer. I see a feminist. When I look at my fellow female members of the Nova Scotia Bar, I see superheroes, strong and brave women who uphold the rule of law (*ex parte* applications, urgent filings, immediate opinions, late nights and early mornings in the office), while "balancing" all the other stuff too, relationships, children, aging parents, volunteer and professional activities. Women who are not afraid to speak their minds, like the writer of the postcard above.

I'm betting we won't all agree on this, but I say, embrace your inner superhero! You may not love the tights, but you gotta love the attitude. To quote Queen Hippolyte (Wonder Woman's mom):

"Go in peace, my daughter. And remember that, in a world of ordinary mortals, you are a Wonder Woman."
