Notes:

- (1) Geographic Distribution: "% of District" refers to the gender split within the district in the case of HRM, 57.1% of the 1,379 practising lawyers are male. "% of Male Population" refers to the gender distribution among the districts in the case of male practising lawyers, 66.2% of the 1,190 male practising lawyers (September 1) work in the HRM. "% by District" refers to the total distribution of all practising lawyers by district.
- (2) Type of Practice Distribution: "% of Type" refers to the gender split within each of the identified types of practice. In the case of Partners, 74.5% of the 462 Partners are male. "% of male population" refers to the gender distribution among the practice types in the case of males, 29.5% of the 1,166 practising male lawyers (June 30) are Partners.

Some percentages may not add to 100% due to rounding. In the case of the "Diversity" percentages, a lawyer may fall into more than one group, therefore those percentages will not add to 100%. The Annual Lawyer Report represents values as of June 30, 2017.
