Congratulations to this year's winner Harshini Arumugam for her paper *Putting Labour Law to Work: The Imperative of Race Conscious Labour Law.*




Harshini Arumugam

NSBS Annual Meeting set for June 19, 2025





NSBS Fee Increases Effective July 1, 2025



Ruck Report Independent Implementation Lead





Award for Mi'kmaq & Indigenous Peoples Excellence in the Legal Profession 2024: Jade Pictou




At Large Council Election Acclamations
